RELEASE, HOLD HARMLESS AND AGREEMENT
NOT TO SUE
COASTAL CONSERVATION ASSOCIATION, ET AL

For good valuable consideration, including without limitation the acceptance of the undersigned's entry or participation in the **Babes on the Bay fishing tournament** (the " Event") and being permitted to participate in certain related activities, the undersigned, for himself and his personal representatives, heirs, guest, invitees, employees and **crew members** hereby (1) RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE the following:

and their Chapters, subsidiaries, related entities, respective members, volunteers, heirs, successors, assigns, officers, directors, employees, agents, contractors and subcontractors (collectively, the "Releasees") from all liability to the undersigned, his personal representatives, assigns, heirs and next of kin, and for all loss or damage, and all claims or damages therefore, on account of bodily injury, personal injury, death or property damage of or to the undersigned, his guests, invitee, employees or crew, during the Event or arising out of or in any way in connection with the Event and related activities or while the undersigned is competing, or participating, regardless of whether caused in whole or in part by the negligence of Releasees; (2) AGREES TO INDEMNIFY AND HOLD HARMLESS Releasees and each of them from and against all claims, actions, causes of action, damages, liabilities, losses and judgments (collectively, the "Claims") of or by all guests, invitee, employees and crew of the undersigned for bodily injury, personal injury, death or property damage which they may suffer or incur during the Event or arising out of or in any way in connection with the Event or related activities, regardless of whether caused in whole or in part by the negligence of Releasees; and (3) ASSUMES FULL RESPONSIBILITY for and risk of bodily injury, personal injury, death or property damage of or to himself, his guests, invitees, employees or crew and his boat and equipment due to negligence of Releasees or otherwise during the Event or while participating in the Event or related activities or while in or on the Event premises and the common properties and recreational areas and adjacent docks, piers and boat slips.

The undersigned agrees to pay all of the Releasees' costs of defending all Claims and further agrees that this Release, Indemnification and Agreement Not to Sue is intended to be as broad and inclusive as permitted by the laws of the State of Texas and that, if any portion of this agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

TOURNAMENT RULES

This is an amateur women fishing tournament.

Entry fee \$80.00 per person postmarked by April 29, 2011.

Late registrations will NOT be accepted on Friday, May 13th.

Up to 4 women and one guide or driver per team. All individuals on the boat must be named on the registration form.

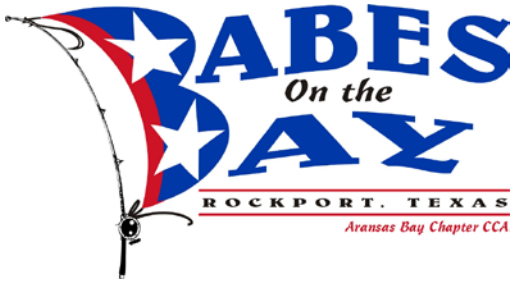
1. No jetty, surf, dock or pier fishing. Fishing area parameters are S of the Victoria Barge Channel and N of the JFK Causeway.
2. Live or artificial bait allowed in divisions 1 & 3 only. One pole per angler. May be assisted by guide or friend in casting, baiting hook or netting. Each entrant must hook and bring fish to net unassisted.
3. Fishing begins at official sunrise on Saturday, May 14th. Time will be posted during the kick-off meeting on Friday.
4. Weigh in no earlier than 12:00 noon, and you must be in sight of the Weigh Master, Bud, by 4:00pm.
5. Eligible fish are 3 trout and 1 redfish. **No over-sized redfish or trout over 25” will be judged.**

PARKS AND WILDLIFE FISHING LICENSE & SALTWATER STAMP ARE REQUIRED

ALL PARKS AND WILDLIFE RULES & REGULATIONS APPLY

A GAME WARDEN WILL OFFICIATE AND RULES WILL BE ENFORCED

6. In the event of a weigh tie, length will prevail. Decisions of the weigh master, Bud, are final.

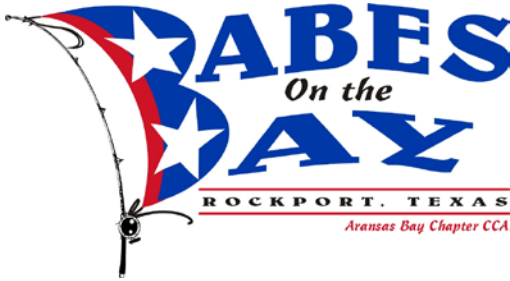

Tournament Rules

- **REDFISH** – A legal Redfish (Red Drum) must be at least 20” and not greater than 28”. This is the size of the Redfish you are allowed to weigh in for the tournament. If you catch one smaller than 20” you are required by law to release it. A Redfish over 28” must be tagged if you decide to keep it, but you cannot weigh-in any Redfish over 28”. **Your team must decide which Redfish to weigh in prior to approaching the weigh master.**
- **TROUT** – A legal Trout (Spotted Sea Trout) must be at least 15”. If you catch one smaller than 15”, you are required by law to release it. You cannot weigh-in any trout over 25”. **Your team must decide which trout to weigh in prior to approaching the weigh master.**
- **FLOUNDER** – A legal Flounder must be at least 14”, any Flounder smaller must be released. The Babes on the Bay tournament will only judge a Flounder that is greater than 15” for the Flounder category.
- **Stringer** – The team stringer consists of 3 trout and one redfish. Put these fish in the team’s fish bag provided at registration. If you have a flounder and/or a redfish eligible for the most spots, place those fish in the bag as well. **Coolers will not be allowed in the weigh in line.**
- **FISHING LICENSE** – You must have a valid/current fishing license with a saltwater stamp from Texas Parks and Wildlife to fish in this tournament. If you catch a Redfish that is greater than 28”, and you want to keep it, you need to put a tag (part of your license) on this fish. Each angler is allowed one of these per year. You can purchase a 1 day all water license and it does come with a tag. **Please fish this tournament by the rules enforced by Texas Parks and Wildlife. Citations for not observing these rules are very expensive; they disqualify your team from the tournament, and could just ruin your day!**
- **“One pole per angler”** – You can have more than one rod and reel on the boat, but you cannot fish with more than one at a time.
- **Assistance** – Someone may assist you in baiting your hook, casting, and netting. It is your job to “set the hook” and reel the fish to the boat or net.
- **Fishing Boundaries** – South of the Victoria Barge Channel and North of the J.F.K. Causeway.
- **Tournament Waiver** – Each participant and the boat driver/guide must sign the waiver.

CASH POTS!

1. Heaviest Red - \$50.00 pot

Your team can enter the cash pots on Friday night only. Do not send this in with your registration fee. The pots will pay 1st and 2nd. 80% to first and 20% to second.

Cash only.

If you have ever been disqualified for any fishing tournament, you will not be qualified to fish Babes on the Bay. All contestants, including minors*, agree to take a polygraph test if required by a Babes on the Bay or CCA Board Member or the Babes on the Bay weigh master. Such test shall be taken at the time and place requested by the Aransas Bay CCA chapter. Failure to take or pass a polygraph will result in disqualification from this tournament and all future "Babes" events. The individual taking the test may be a team member or the guide/boat driver.

***If the contestant is a minor, a parent or legal guardian shall agree for the minor to submit to such polygraph testing.**
